Stages of Implementation: Decision Rules

Level	Criteria for Mastery
Level I: Training/Initiation	<ul style="list-style-type: none"> • Self-Assessment: 80% or higher across each of four areas for school-wide implementation (Tier 1) <ul style="list-style-type: none"> ○ Leadership, Continuum of Behavior Support, Teaching/Implementation, Evaluation • TIC: 85% or higher • SET: 85% or higher
Level II: Implementation	<ul style="list-style-type: none"> • Self-Assessment: 80% or higher across each of four areas for school-wide implementation (TIER 1) AND __% on targeted group (Tier 2) and individual intensive interventions (Tier 3) • BoQ: TBD
Level III: Maintenance	<ul style="list-style-type: none"> • Self-Assessment: 80% or higher across each of four areas for school-wide implementation AND __% on targeted group (Tier 2) and individual intensive interventions (Tier 3) • BoQ: TBD
